

Terms and Conditions

1. The Sunway University College A-Level Scholarships are applicable for the programme of Cambridge GCE A-Level at Sunway University College in Malaysia only and are not applicable for period of study beyond the maximum duration of one and a half years.
2. The award of a scholarship takes the form of reduction in the tuition fee payable; it is not a cash award. In the event where the scholarship is less than the tuition fee, student is responsible for the outstanding fee amount. In the event where the scholarship amount awarded is more than the tuition fee, student will be awarded the tuition fee amount only.
3. The tuition fee waiver will be implemented from the 1st semester of the programme onwards.
4. The terms of the scholarship disbursements are determined by Sunway University College.
5. The quantum of awards to successful applicants is at the sole discretion of Sunway University College.
6. Sunway University College reserves the rights to decide on the number of scholarships to be awarded.
7. This scholarship is open to all students (Malaysian only) sitting for the Sijil Pelajaran Malaysia (SPM) examination in year 2010.
8. English 1119 will not be considered when granting the scholarship.
9. The scholarship offered is for the January 2011 intake only. Special arrangements will be given to students selected for National Service in the year 2011.
10. Students receiving scholarships / financial assistance / bursaries from other bodies are not eligible for these scholarships.
11. Applicants who had won scholarships or bursaries in any competition organised by Sunway University College may combine the amount won with the Sunway A-Level Scholarships up to the maximum amount of the total tuition fee of the Cambridge GCE A-Level programme based on 3 subjects (excluding Thinking Skills) only.
12. The scholarship offered is subject to other terms and conditions, which will be stated in the Letter of Offer to be signed by the parent / guardian. Sunway University College reserves the right to request for extra documentations and/or an additional interview with the applicant.
13. Sunway University College reserves the right to alter, add or delete any of the terms and conditions and the scholarship scheme at any point in time as and when Sunway University College deems necessary.
14. Sunway University College reserves the right to review scholarships awarded on a semester basis. In exceptional cases, scholarships may be withdrawn at any time in the event of gross misconduct or failure to meet the required academic grades.
15. In the event that the recipient withdraws from the programme, is suspended or terminated by Sunway University College at any point in time, before the completion of the programme, the scholarship shall automatically be terminated. However, if recipients on the above-mentioned status are due to medical reasons, they may retain their scholarships, subject however to the absolute discretion of Sunway University College by providing the supporting medical report from Doctor acceptable to Sunway University College.
16. This scholarship does not cover general fees, exam fees, re-sit or re-enrolment and accommodation fees which must be paid by all scholarship recipients where applicable.
17. In the event of a dispute on the eligibility for the scholarship, the decision made by the Scholarship Committee is final and no appeals will be entertained.
18. The successful applicant is required to pay the application fee & registration fee (non-refundable) upon acceptance of the Sunway A-Level Scholarships award and to pay the balance of the fees due (after deduction) by the commencement date of the programme, failing which the scholarship award will be considered null and void.
19. Sunway University College shall not be held liable for any injuries or mishaps that may befall candidates at or in passage to the interview sessions.
20. Applicants must be of respectable character and should not have any criminal convictions or records and should not have been involved in any misconduct which may bring Sunway University College into disrepute.
21. Sunway University College reserves the right to involve the scholarship recipients in interviews, advertisements, photography or other publicity related activities for the purpose of promoting the educational institution.
22. All scholarship recipients are required to fulfil a minimum of 5 hours to assist the A-Level Department and Sunway University College in extra-curricular activities and events.
23. All scholarship recipients who obtain a minimum of 3 full As and a minimum B for Thinking Skills in their actual Cambridge GCE A-Level (A2) examination results will be able to convert this scholarship into a full scholarship whereby the amount of the total tuition fee paid will be reimbursed at the end of the programme.
24. All applications must be received by the 13th August 2010 before 5.00pm. Late applications will not be considered.
25. Shortlisted applicants will be notified by Sunway University College of the date, time and venue of the interview to be conducted at a location nearest to the applicants.
26. Successful candidates will be informed in October 2010. They must confirm acceptance of the scholarship latest by 19th December 2010.
